THE LAST STEP: PREPARING THE COUNTRY FOR THE FULL EU MEMBERSHIP

he Tenth International Conference "Albanian Studies Days" is calling for paper submissions focusing on the topics related to The last step: preparing the country for the full EU membership.

EU integration has consistently been the only project that Albanians have embraced since the fall of communism with the same pathos and support. Important milestones have so far been achieved: a Stabilization and Association Agreement is in force since 2006, a document which regulates not only trade in goods and services, but many other dimensions of investment and economic governance issues. Some degree of flexibility in the movement of people is also achieved. From year 2020, Albania was accepted by EU members to open negotiation for a full membership status. However, negotiations have started only from the last year, 2022. This will bring the country in the final step of the very long journey to become a full member of the European Union.

Given the complexities of the process and the need to involve all actors of the society, this year Albanian Studies Days (ASD) Conference will be dedicated to research on the implications of this process.

Researchers interested in the mentioned issues are encouraged to participate in the conference, which brings together researchers from different areas, such as politics, economy, finance, IT, engineering, law, sociology, anthropology, psychology, education, arts, medicine, etc. The aim of this conference is to get better insight and exchange ideas and experiences, and to map future research directions in a broader context.

The path towards such a complex process has been prolonged and hindered by various political, economic, and social factors and events, be they domestic of EU-related ones, but finally Albania has commenced the long-awaited EU accession process. The EU integration process has been evolving and changing through times, given some remarkable events, which has affected the EU approach and attitude towards the Western Balkans (WB) countries. Along with the difficult political consensus within EU, the las decade's financial crisis in the EU has transformed the whole EU architecture, including the ECB and Euro system in general, along with the "EU appetite" for new members form WB countries. In this regard, the Albanian government, economy, society, and relevant institutions are faced with multiplex challenges, given the stage of development in all the respective areas and the complex harmonization process with the Acquis Communautaire. Therefore, the EU accession process calls for diligent endeavors and preparations from all institutions, structures, and individuals, which are, or will be, in charge of implementing and leading various aspects of such a comprehensive process.
